## **Government must invest in Gillieston Public School**



Jenny met with concerned parents, carers, students and community members recently at Gillieston Heights Community Hub to hear their concerns and pressure the NSW Government to act.

Recently I invited NSW Premier, the Hon Dominic Perrottet MP and Minister for Education and Early Childhood Learning, the Hon Sarah Mitchell MLC to attend a meeting to hear firsthand from concerned parents and carers about the significant infrastructure issues at Gillieston Public School.

Unfortunately neither could attend, however Minister Mitchell has promised to listen to all of the issues raised.

For some years now I have been campaigning for the Government to take urgent action to upgrade the school. When I was first elected in 2015, there was still a dirt floor in the boy's ablutions block, the school zone didn't cover the school gates and the school is still not connected to town sewer.

It is simply not good enough that over 260 students are learning in a school with only two permanent buildings. Students and teachers deserve to be learning and teaching in 21st century permanent, flexible and innovative learning spaces.

Please continue to write to my office so I can pass on your feedback to the Minister. We need everyone to pressure the NSW Government for these much needed upgrades.

## **\$400K Boost For Maitland Community Organisations**

Recently I had the pleasure of announcing \$400,000 for 19 projects through the NSW Government's 2021 Community Building Partnership Program.

## **NSW Government Disregard for Morpeth Heritage**

I have been working with a number of community groups including "It Must Be Morpeth" business chamber, the Morpeth Heritage Conservation Group and members of the Morpeth Bicentennial Committee about the NSW Government's failure to properly maintain the Morpeth Railway Station.

This has included letters to a number of Ministers and meeting with stakeholders at the site a few weeks ago. 'It Must Be Morpeth' is hoping to convert the premises into a commercial enterprise to provide Morpeth with an important tourist attraction and provide additional economic benefits to local businesses. It was good to connect some of those interested parties.

The Soil Conservation Service of Local Land Services is using part of the building however it has fallen into a state of disrepair. Morpeth relies on tourism and has been significantly impacted by the COVID pandemic.

I have written again to the Minister for Agriculture, the Hon. Adam Marshall MP and hand delivered photos that I took at the site. It was disappointing to see recent damage which needs to be rectified. The NSW Government has neglected this important heritage site for over a decade and it should be restored as a matter of priority!

## **Government Fails Local Communities on Taxis**

As Shadow Minister for Regional Transport and Roads, many people have contacted me to raise their concerns about the NSW Government's proposed point-to-point transport reforms.

These "reforms" would see taxi licences scrapped, with the Government considering compensation of around \$50,000 for a maximum of only 2 plates, regardless of how many taxis are operated, despite plates being purchased in some cases for nearly \$400,000.

This will leave regional communities without taxis when surrounding cities have peaks such as weekends and during festivals. In communities where public transport is patchy, taxis are vital to overcome transport poverty.

In budget estimates hearing NSW Labor called on the Deputy Premier and Leader of the Nationals, the Hon. Paul Toole MP to reveal which towns will lose taxis due to the Government's botched reforms of the point to point industry, however he has so far failed to produce the report.

At the hearing Labor uncovered the shocking fact that \$100 million of the \$142 million support package that was promised five years ago, is still sitting in Government coffers. It is clear the NSW Government either doesn't understand or doesn't care about the pain and hardship licence holders have experienced over the past six years.

I am very concerned about any plan that does not deliver fair compensation to taxi plate licence holders and will continue to meet with taxi plate holders and industry representatives. NSW Labor will continue to monitor this situation closely and advocate on behalf of all taxi place licence holders in NSW.

Hard working small business owners in Maitland and across the state deserve more!

## Level Crossing Safety - #WhichCrossingNext

I recently spoke on a petition debate after 20,000 signatures were received calling for level crossing safety improvements.

Sadly Maddie Bott lost her fiance Ethan Hunter and his work colleague Mark Fenton in a tragic level crossing accident earlier this year.

Maddie's bravery in advocating on this issue at a time of her most personal grief is inspiring and courageous. Maddie spent weeks door knocking and attending local shops and stalls to collect the 20,000 signatures needed to bring on a debate.

Shamefully the Government wouldn't let many other members who wanted to contribute to the petition debate speak. This issue should have been above politics as many communities in NSW have seen, serious injuries or even fatal accidents at these sites. dangers of level crossings, and put in place a targetted risk mitigation strategy to increase safety at level crossings.

NSW Labor has committed to working with impacted families and the relevant stakeholders to improve the safety at level crossings. As Maddie would say 'It doesn't matter how long this takes, we will tackle this one track at a time, for Ethan and Mark'. #WhichCrossingNext

## **UPDATE - Congestion on our local roads**

Thank you to everyone who signed the 'Fix Our Roads in Maitland - Give Us Our Fair Share' petition to date and attended the community meeting earlier this year.

Due to COVID, although Deputy Premier and Minister for Regional Roads has agreed to attend another community meeting, we have been unable to confirm a date.

We need the Deputy Premier to see first-hand the challenges experienced by people in Maitland as a result of delays in addressing our poor state roads infrastructure.

I hope a community meeting can be scheduled in early 2022 but in the interim, I have raised concerns from the community meeting earlier this year through a Notice of Motion and a Private Members Statement in the Parliament.

In the meantime, Transport NSW (TfNSW) has advised that they will conduct a study covering Thornton Road, Metford Road and Raymond Terrace Road between McFarlanes Road and Melbourne Street.

TfNSW will be working with the Department of Planning, Industry and Environment, Maitland City Council and developers to assess potential land use changes and identify necessary transport infrastructure and service improvements, including public transport initiatives to encourage mode shift, to accommodate future demand.

TfNSW are also exploring short-term upgrade options at

the busy intersection of High Street and the New England Highway to reduce congestion on the surrounding road network, as well as longterm solutions to issues at intersections on Melbourne, Lawes and Cumberland Streets.

Please continue to share your issues and congestion stories with me so we can flood the Deputy Premier's office with representations from concerned members in our community to achieve much needed funding for our roads.

# Please give us a new MBS Licence for Maitland's MRI Machine

To the Honourable Speaker and Members of the Legislative Assembly of New South Wales. This Petition of the citizens of New South Wales brings to the attention of the House that the \$500 million New Maitland Hospital which is due to open in early 2022 includes a state-of-the-art 3T Tesla Magnetic Resonance Imaging (MRI) machine that does not have a Medicare Benefit Schedule (MBS) licence to use it.

If the Federal Government doesn't open a funding round, and approve the New Maitland Hospital for a licence, Maitland's brand new MRI machine will only be accessible to inpatients and emergency cases via the Emergency Department.

We call on the NSW Government to urge the Federal Government to immediately open Invitations for an MBS licence for the New Maitland Hospital MRI's machine, so that everyone across the region can access and afford this life saving imaging.
