## **NEW SCHOOL FOR GILLIESTON**

After 8 years, we have a commitment for a new 21st century public school at Gillieston Heights. Congratulations to all the parents, community and others who have worked with me to get this fantastic win!

After petitions, speeches in Parliament, media stories a public meeting and many submissions to the NSW Parliamentary Inquiry into Schools Infrastructure, we got an announcement in June that \$1.73 million had been committed in the budget for the redevelopment of Gillieston Public School.

We wanted an airtight commitment that the school would indeed be fully upgraded, and I am so pleased to announce that in the recently released "School Infrastructure NSW 2022-23 Delivery Strategy", Gillieston Public School is one of just 23 major capital works projects across the state, with a funding estimate of between \$25M and \$75M.

While I am pleased we have finally got the redevelopment of Gillieston Public School (and the completion of redevelopments at Bolwarra, Rutherford Technology High School, Rutherford Public and Ashtonfield, we know that there is more to do.

The Government has admitted they are one primary school and half a high school short for our growing populations and areas such as Thornton and Chisholm, and Lochinvar need urgent investment in new permanent school infrastructure which I will continue to fight for.

## **HEALTH EMERGENCY**

Health care in NSW is in a state of crisis. We face a chronic shortage of health workers, with experienced workers cutting their work hours or leaving the system altogether because they aren't getting enough support.

We have fewer ambulance paramedics per person than every other state except WA, and the worst ambulance response times compared to every other state bar one.

People in NSW are now waiting longer than ever to get an ambulance, to be treated in an emergency department and for elective surgeries. In the last 3 months 76,000 patients left emergency without completing treatment, and one in 10 patients spent over 21 hours in 16 minutes in an emergency department waiting room.

Alarmingly, at Maitland Hospital almost 1 in 4 patients left emergency without completeing treatment. These figures show the dire state of our health system.

HSU Members and NSW Nurses recently visited Parliament and shared stories of sianificant understaffing and the sacrifices and conditions they are enduring, including double shifts, cancelled leave, burnout and exhaustion!



It's not fair on our hardworking healthcare professionals to have to manage a system that is stretched to its limits.

Our brand new and shiny hospital cost half a billion dollars, but we don't have enough staff to open all the wards.

We need new rural and regional paramedics and safe staffing levels across our hospitals to ensure our health system can function properly.

I successfully advocated for new social housing affordable for all residents, including public apartments in East Maitland to replace old and affordable housing tenants, renters and cottages which had fallen into disrepair. The \$6.14 first home buyers. million project consists of 18 new units, seven two-bedroom and 11 one-bedroom units. But this does very little to place over 700 applicants listed on the social housing waitlist.

The Government recently announced eight new core and cluster refuge units for Maitland, which has the highest domestic violence rates in NSW but they won't come online until 2024.

#### **RURAL ASSISTANCE GRANTS AFTER THE FLOODS**

A number of rural property owners have found it difficult to access financial assistance through the NSW Government because they are unable to show that they derive a majority of their income from their small business.

I raised this issue as former Shadow Minister for Primary Industries and advocated strongly to ensure there was an alternative solution.

Once approved, eligible primary producers can access \$5,000 in assistance up-front, with a further \$20,000 in financial assistance available thereafter upon submission of valid tax invoices. ## **EDUCATION CRISIS - TEACHER SHORTAGES**

Sadly, over more than a decade the Liberals and Nationals have failed to invest in public education across the state. So many Teachers have approached me to tell me they are fed up, exhausted, and feel undervalued and undermined by staffing shortages.

There is no quick fix for the sector, but as a start we must see a restoration of respect for our remarkable educators. They deserve to be valued and given a seat at the table whenever there is a decision being made about the profession they understand so intimately.

We are facing a chronic shortage of 11,000 teachers over the next decade, while the number of temporary teachers working in our schools has almost doubled.

Teachers shortages mean students don't know if they will have the same teacher next week, many are missing out on vital lessons and classes are regularly cancelled.

NSW is falling behind in national international rankings on literacy, numeracy and science. Education is a powerful tool for breaking the cycle of poverty, for supporting children's development and for closing the gap in social inequality.

There are too many casual teachers, and not enough permanent ones, administrative loads must be reduced and we must keep mobile phones out of our classrooms. Our students' future is too important to not invest in our teachers and other education staff!

## **300 Years Service for Maitland JP's**

## **IPC TO DETERMINE MARTINS CREEK QUARRY**

The Independent Planning Commission (IPC) has Government was shamed into returning the been holding hearings and taking submissions funds. into the proposal on the Martins Creek Quarry. Many people are concerned about the impact of truck movements along the route through Maitland and I have met with a number of constituents and encouraged them to make submissions. I recently wrote to residents in Lorn and Bolwarra (those mainly impacted by the route) to tell them about the opportunities to have their say on the development.

After advocacy from myself and Councillor Loretta Baker in 2104-15, Maitland City Council was successful in getting a grant of \$1.2 million from the State Government to undertake road widening and repairs on Tocal Road to improve saafety and reduce noise.

This funding came from the \$543 million Fixing Country Roads budget, which the NSW Government defunded by \$80 million in 2019. It is only through my advocacy as Shadow Minister for Regional Transport and Roads that the NSW

If the development is approved by the IPC, Maitland (and those areas to the north of us) must get our fair share of the Fixing Country Roads budget and I will work hard to achieve this. I know this is also an issue for Thornton and Woodberry residents.

I want to thank the Martins Creek Quarry Action Group, who briefed me extensively, and advised me of a number of other quarries in southern NSW where surrounding communities have had significant infrastructure built to ensure the liveability and safety of their communities are maintained.

## NEW BOUNDARY CHANGES

To ensure the number of electors within each district approximately remains the same over time, the Constitution Act 1902 requires that electoral district boundaries are adjusted.

This process is called a redistribution, and takes place after every second State general election in NSW.

Sadly due to the significant growth of Maitland, from the next election, I will no longer be the representative for constituents living in Bolwarra, Bolwarra Heights, Largs, Lorn, Phoenix Park, Maitland Vale, Melville, Mindaribba, Lambs Valley, Luskintyre, Hillsborough, Rosebrook, and Tocal.

#### A FAIRER GO FOR THE TAXI INDUSTRY

NSW Government legalised rideshare and deregulated booked point to point transport services, creating a massive drop in value of taxi plates, leaving those who purchased or borrowed against what were once secure government back investments with heavy financial losses.

Taxi waited owners have too many years for the NSW Government to put an acceptable compensation package on the table, and the Government still has no plan for ensuring the retention of taxi services in rural, regional and remote areas, or ensuring the availability of wheelchair accessible taxis.

As Shadow Minister for Regional Transport and Roads, I have spent many hours advocating on

It is now seven years since the behalf of taxi plate owners with the Government, and listening to taxi owners, the NSW Taxi Council and the Taxi Owners Small Business Association of New South Wales (TOSBA) about what needs to happen to ensure continuity of services in the regions and for people with mobility issues, and that taxi plate owners received the best deal.

> It was only through the advocacy of NSW Labor that taxi operators ended up with the final package of \$905 million, which provided a significant increase for regional taxi plate holders, as well as removing the caps on the number of plates that can receive compensation. Labor has fought hard to ensure the payments are treated as a capital event to ensure income tax is not inadvertently applied (as has happened in the past).

#### MAITLAND FLOOD RESPONSE

I am grateful to emergency service volunteers and staff, Maitland City Council staff and the various State Government agencies community who all worked so and learnt of the \$50 million hard together to ensure that our community has been safe through a very wet period over the last two years.

Consecutive significant weather events have taken a toll on the Levee Banks in and around Maitland, notably at Pitnacree, Horseshoe Bend and Cultivation Road at South Maitland.

When the Premier visited the Emergency Operations Centre during the floods he was provided a briefing and members of from emergency personnel, backlog of flood works required from the March 2021 event - 15 months previously.

> But it's not just the the \$50 million from the March event; there was significant damage from the November 2021 floods, which was not recognised by the Government which did not even have an up-to-date flood plan a that time. We did get funding announced in the

budget after the March event. however then we had the July event.

Repairs have been completed at the Maitland Ring levee, at Maitland Showground and works are continuing at Maitland levee, at Horseshoe Bend and at Pitnacree levee, but there is still more to do to ensure the levee banks provide protection for our people, property and infractructure.

I urge the NSW Government to escalate these events. Whilst wet weather slows it down, the delayed responses by the Ministers have not helped.
