New Maitland Hospital on the waiting list

For five years Maitland has been waiting for a new hospital. Maitland grows by five people every day and we need better health services to meet the demand.

Labor spent \$10 million to upgrade the existing Maitland Hospital emergency department which was completed in 2011.

We have the promise of a Lower Hunter Hospital, an \$8 million sign on Metford Road, and a vague promise from Minister Skinner's office last year that construction would start in this term of government, but that could just be a shovel in the ground in March 2019.

The government has allocated \$6.2 million in the 2016-17 budget for the new hospital. The estimated expenditure to date on the project is \$13.5 million, yet no ground has been broken and no sod has been turned.

The government had promised to spend around \$17 million by now, but is \$4 million behind budget on this promise. A further \$25 million was promised by the Baird Liberal Government at the 2015 election.

What is the timeframe? When will it be built? How will it be run? What will happen to our existing Maitland Hospital?

Despite the best efforts of our hardworking hospital staff, our patients face long waits for specialists and long delays for elective surgery.

Five years ago we were promised a new \$800 million John Hunter-sized hospital with 630 beds. That was in addition to the 188 at our existing hospital

Then in 2014 we had consultations. Funding was halved (to \$400 million), beds were halved (to 315) and we were told the existing hospital would probably close.

Instead of a major tertiary public hospital, in addition to the existing public hospital, we are left with the promise of a rural referral public-private partnership hospital with a helipad to fly out the most difficult cases. Cancer patients will still need to travel to the Mater.

In addition to better health outcomes for our growing region, the hospital will provide much needed jobs.

This failure to get on with building this hospital is an appalling snub for Maitland, and our community should no longer be held to ransom.

It's been a busy first year for me as your local State Member.

Maitland faced another flood and two East Coast Lows this year. It's a shame that the NSW government failed to provide any funding towards raising the road at Testers Hollow, even after Federal Labor's recent announcement with myself and Mayor Cr Peter Blackmore.

The government has allocated a mere \$6.2 million in this year's budget for the new hospital, with \$4 million of this being what they underspent last year, proving they are 25% behind budget.

Positively, \$20 million renovations to Rutherford Technology High were recently unveiled, the upgrade of Maitland No. 1 Sportsground is under way, and renovations to the Town Hall have been completed. I will continue to lobby for important projects for you.

As recently appointed Shadow Minister for Small Business, and Shadow Minister for the Prevention of Domestic Violence and Sexual Assault, I have met with many groups throughout NSW to consult with communities about these portfolios.

While domestic violence and sexual assault have both increased dramatically in the past two years, I have been pleased to work with Carrie's Place, police, our premier sports clubs and the Maitland Business Chamber, as well as many others, to develop new ways to reduce violence in our community. We can make Maitland a safe place for everyone. This is one of my highest priorities.

Green Hills plan boosts jobs

The \$375 million redevelopment will be great for the Maitland community because of the thousands of new construction and permanent retail jobs it will create.

The ground breaking signified the start of major construction activity at Green Hills, which will continue over the next two years.

Stockland Green Hills will more than double in size to around 70,000 square metres, featuring the first new-format David Jones department store in the Hunter, as well as a new JB Hi-Fi Home store and a new Harris Scarfe department store. The developer also hopes to include a new cinema.

Community Building Partnership grants open

Applications are now open for funding to community groups to build, refurbish or maintain facilities, under the 2016 Community Building Partnership program. Applications can also include the purchase of capital equipment.



\$200,000 will be split between groups in the Maitland electorate, and the minimum funding request is \$2,500.

Applications close on Friday 22 July, and successful groups will be announced in December.

Last year funding was shared between nine groups, including \$70,000 for Maitland Rugby Union Football Club for an electrical transformer and lighting upgrade at Marcellin Park, and \$63,676 for Maitland Tenambit BMX Club to stormproof its track and install a safety start gate.
